

MANCHESTER TOWNSHIP HISTORY

Founded by William Torrey for its namesake, a British manufacturing city, Manchester Township was formed through an Act of Congress on April 5, 1865. Manchester was the seventh municipality formed in Ocean County. The other municipalities were Little Egg Harbor Township in 1740, Stafford Township in 1750, Toms River formerly Dover Township in 1768, Jackson Township in 1844, Union Township in 1846 and Brick Township in 1850.

After receiving 640 acres of land in what is now present-day Lakehurst Borough, Mr. Torrey and his wife Adelaide moved to Manchester in 1841. A real estate promoter and developer, Mr. Torrey spent the years 1841 to 1865 engaged in the sale of properties he owned in Manchester Village. He dreamed of establishing Manchester as an important rail and industrial center and thought it would be better served as an independent political entity.

In furthering his vision, Mr. Torrey is responsible for constructing the railroad in downtown Lakehurst that became operational in 1863 as part of the Raritan and Delaware Bay Railroad, allowing for connections with other lines to the Jersey Shore and Philadelphia.

The Whiting section of Manchester was named in 1861 by Nathan C. Whiting. He came from New Haven Connecticut and erected a sawmill. The first post office was built in 1841 as well as a Presbyterian Church.

Since its incorporation, Manchester Township's boundaries have remained the same except for the secession of the Borough of Lakehurst in 1921. At the time of incorporation the population was 1,054. As of the 2010 census Manchester's population was 43,070.

1896

3/10/1896 – The money from hotel licenses and railroad and canal taxes be expended on roads. The amount of \$250.00 on Toms River Rd. and \$150.00, on Ridgeway Road. The remaining funds used for the remainder of Township roads.

2/25/1897 - Ordinance passed to regulate the use of bicycles and tricycles and other vehicles to carry a lamp to be kept lighted between one hour after sunset and sunrise and must be able to be seen 100 yards away. They are required to carry a suitable

alarm bell attached to the handle bar that could be heard 100 feet away. The speed cannot exceed 8 miles per hour. They cannot ride on sidewalks and violations are \$5.00 per offense.

2/25/1897 - Ordinance passed to carry on the business of a peddler within the limits of the Township without having to obtain a license from the Township Committee.

He appeared before Vice Chancellor Pitney in Newark in November 1906 on the application for injunction. The application was refused and Rogers paid all costs associated.

8/30/1911 – The Township sold all right, title and interest in the Shark River Poor Farm in the Township of Neptune, County of Monmouth. The Shark River Poor Farm was owned collectively by Wall Township, Atlantic Township, Middleton Township, Howell Township, Brick Township, Dover Township, Berkeley Township and Manchester Township. A Poor farm is maintained at public expense for the support and employment of needy persons.

5/30/1911 – The first Indianapolis 500 was held; being won by Ray Harroun.

4/5/1912 - The money received from the sale of the poor farm was used to purchase a suitable lot on Union Ave. and rest on it a Town Hall, a lock up and purchase a chemical engine. The money received from the sale was \$3500.00

7/7/1913 - An ordinance to establish a fire department in the Township of Manchester creating the company for the use of the Township fire apparatus, determining how many members the company shall contain, the qualifications for memberships, the officers of said company and of said department, the mode of appointment of said members and officers and their powers and duties.

12/5/1913- Sealed bids for the construction of town hall were received from John E. Reynolds of Lakewood and LeRoy H. Richmond of Lakewood. LeRoy Richmond was awarded the contract in the amount of \$3,586.00 as lowest bidder.

4/7/1921 - 1920 – Borough of Lakehurst of created out of the Township of Manchester. A committee of 3 was appointed. A Committee of three from Manchester and one from Lakehurst were formed to divide all money, assets and liens of any kind.

4/15/1921 – The Committee determined that streets and public places of Lakehurst should be lighted by electricity and it is more advantageous for the Township that it contract with the Lakewood and Coast Electric Company for a supply of light for said streets and public places for a term of five years rather than provide a public lighting plant. The contract would furnish sixty thirty two candle power incandescent lights at the rate of \$18.00 per lamp per year.

2/26/1926 – The Township Committee issued a Notice that all dogs should be kept in confinement for two weeks due to dog recently killed at the Lakehurst Post Office was found to be a Mad Dog. The dog had bitten a dog at Downs Saw Mill and also bit a dog in Whiting. This Notice is to safeguard the people.

8/4/1931 – The Committee supported the consolidation of the Pennsylvania and Reading Railroads in South Jersey. The consolidation would protect the public welfare and future development of South Jersey.

9/4/1931 – The School Board asked the Committee to split the cost of wiring the school house for electric lights. After discussion the matter would be further considered.

11/12/1931 – A Special Meeting of the Committee was called for the purpose of a plan to meet the State Aid Fund for emergency relief of the unemployed. A number of residents of Manchester Township were out of work and desired employment on straight road work of under the emergency relief plan.

1932

4/1/1932 – The East Coach Company applies to the Township Committee for the consent and permission for the purpose of operating its passenger buses on the highways of the Township. They will carry passengers from Trenton to Seaside Heights.

10/7/1932 – It was found that there was a need for food for the unemployed for the month of November 1932. However, there were insufficient funds in the poor fund. The Committee applied for aid to the State Emergency Relief Administration in the amount of \$250.00 for the month of November to feed the unemployed.

12/5/1933 – Manchester Township allowed the issuance of Liquor Licenses in the Township for a cost of \$250.00 per license. This was after the State of New Jersey adopted Senate Bill No. 611 allowing the sale of intoxicating beverages in New Jersey on November 28, 1933.

2/21/1936 – Work on the Pine Lake Park dam was being completed by the WPA funds. The Committee called this meeting to make sure that Manchester was working on proper title of the ownership of the lake surrounding the dam.

6/4/1937 – Michael Mazzola, Chief of Whiting Volunteer Company #1 formally asked the Township Committee for land to build a new firehouse.

5/6/1937 – Hindenburg disaster: The LZ 129 Hindenburg caught fire, crashing at the Lakehurst Naval Air Station in Lakehurst, New Jersey after departing from Franklin, Germany; killing thirty-five passengers and one ground crewman

5/27/1937 – The Golden Gate Bridge opened in San Francisco

10/30/1938 – Orson Wells performed a broad cast of *The War of the Worlds*

1939

2/4/1939 – Disney's Snow White and the Seven Dwarfs became the first full-length animated film

12/1/1939 – The Township Committee adopted an ordinance making gambling unlawful within 1000 feet of any public school or church or any such business establishment. Any person violating the ordinance shall pay a fine of \$50.00.

1940

1/5/1940 – The Committee introduced an Ordinance to issue licenses for the sale of alcoholic beverages at retail, limiting the number of such licenses, fixing rules and regulations regarding the licenses and repealing any prior ordinance. The number of consumption licenses would be limited to five, one club license and one distribution license.

1/5/1940. – C.S. Earley was appointed as Township Treasurer at a salary of \$100.00 per year. His duties were to handle the receipts and disbursements of Township funds rendering the required reports of financial condition at the regular meetings of the Township Committee

1/16/1940 – The Clerk was to be paid at a sum of \$5.00 per meeting night and at a rate of 62.5 cents per hour for other work in connection with said office other than meeting nights.

1941

5/2/1941 – The Township Committee instructed the Municipal Clerk to write the commanding officer of the United States Army at Fort Dix expressing the appreciation of the Township Committee the services rendered by them in the use of men and equipment during the disastrous forest fire passing through Manchester Township in the month of April.

2/23/1941 – American Nuclear chemist Glenn T. Seaborg with fellow U.C. Berkeley researchers, discovered the chemical element plutonium

1943

1/1/1942 – The Clerk brought to the attention of the Committee the need of a dog census and make report no later than February 1, 1942 to the State Board of Health. George Mick was appointed special officer and dog enforcing official on January 6, 1943.

2/5/1942 – Mr. Mick resigned as dog licensing officer and Lemuel Earley was appointed to the position.

6/11/1943 - Three liquor licenses were issued in the amount of \$400.00 each to Peter Allegrina, David Hilliard and Harry Waldman.

10/1/1943 – Mr. Hansen, in charge of grounds at Pine Lake Park, brought before the Committee the advantage of lowering the water in the Lake this winter, allowing portions of the lake bed to dry out for purpose of beach improvements on the approach of spring and the bathing season. Mr. Miller, in charge of grounds, said the matter would be considered.

1944

6/2/1944 – Lt. Col. John T. Daly Post Judge Advocate of Fort Dix asked for permission to use 12000 acres for maneuvers. Some of the area proposed was near the gravel pit that the Township utilized. Chairman Reynolds suggested withhold granting permission until an easterly boundary line was established.

6/22/1944 – The G.I. Bill was signed into law

1946

1947

1/3/1947 - Mr. Neils M. Hansen was appointed special officer and paid the sum of \$25.00 per year for looking after gates and grounds in and around the lake at Pine Lake Park.

1/3/1947 – The Township Committee added an item of appropriation into the 1947 for the erection of a new garage, new road equipment, and aid in the purchase of new firefighter's equipment, all of which will not increase the tax rate very much above previous figures.

4/15/1947 – Jackie Robinson of the Brooklyn Dodgers broke the color line in Major League Baseball

7/1/1947 – Mr. James Bettio made application to the Township Committee to construct and operate a Plenary Retail Distribution License. It was to be located at the corner of Ridgeway Cassville Road and Naval Air Station Road and would be called Jimmy's Package Store.

8/1/1947 – The Township Committee accepted a deed from the Pine Lake Park Tax Payers Protective Association for the private road from Bride 8th Ave. to Bridge 9th Ave. width of fifteen feet. It will become known as a public road in Pine Lake Park.

1948

4/13/1949 – The Nuremberg Trials ended, with the convictions of 24 major Nazi political and military leaders, among others.

5/7/1948 – An Ordinance regulating and licensing junk yards In Manchester Township was introduced.

6/4/1948 – Bids were opened for the erection of a municipal garage in Whiting. The only bid received was from Joseph Takacs in the amount of \$5975.00.

9/3/1948 – It was noted that the construction of the municipal garage had started in July by Mr. Joseph Takacs who was the lowest bidder.

1949

NATO formed

Germany divided into East and West

1950

6/2/1950 – The first hog farm was started in Manchester.

6/17/1950 – Joined the New Jersey State League of Municipalities

6/24/1950 – Dedication of Town Hall building located at the corner of Route 530 and Manchester Blvd. across from Bowker field.

7/7/1950 – Public dump – an offer is made by William S. Jackson, President of National News Paper Sales Corp., and accepted and signed will be made designating the boundary line of the dump.

7/7/1950 – A delegation from Pine Lake Park made a report of the disorderly action of people using the bathing beach: their lack of proper attire, some without any, trash left, loosening the rail on the bridge, and children endangering their lives by playing on the walls of the dam.

10/2/1950 – The comic strip *Peanuts*, Charles M. Schultz, was first published

11/3/1950 – Eight pictures were presented to Township Council of the activities of Manchester Day.

2/2/1951 – The Township Committee canceled the taxes on the Keswick Colony formerly Cranmer Farm for the year 1951 as it is now an institution.

2/27/1951 – The Twenty-second Amendment to the United States Constitution, establishing term limits for President, was ratified

9/7/1951 – The Township Committee received application for a Club License from the Pine Lake Park Tax Payers Association. The fee was \$100.00. The Club had been meeting since 1941 at their location at Morningside and 8th Ave. in Pine Lake Park.

1953

Thirty-Fourth President of the US is Dwight David Eisenhower 1953-1961

2/13/1953 – The Township Committee introduced an ordinance creating an additional election district in the Township of Manchester. They shall be called District No 1. – Western and No. 2 – Eastern.

7/19/1953- The Korean Armistice Agreement was signed, ending the Korean War

1954

5/7/1954 - Mr. Christofferson & Mrs. Bowker, aid in the sum of \$100.00 toward Completion of skating rink on the athletic field in Whiting.

5/7/1954 - Majority Vote Wins, in favor of Bingo and Raffle Law of April 20th.

8/6/1954 - Letter filed and received from A. Paul King, Chairman of Ocean County Civil Defense & Disaster Control, stating that Ocean County is now in operation and connection with State and Federal Governments.

11/11/1954 - Chairman of Manchester was asked to form a committee for the First Veterans Day Celebration.

12/23/1954 – The first successful kidney transplant on a human was performed in Boston

1955

4/15/1955 – Ray Kroc opened the first McDonald's fast food restaurant in Des Plaines, Illinois

7/17/1955 – Disney opened at Anaheim, California

12/1/1955 – Rosa Parks was arrested in Montgomery, Alabama after refusing to give up her bus seat to a white passenger, inciting the 386-day Montgomery Bus Boycott led by Reverend Dr. Martin Luther King Jr.

12/5/1955 – The American Federation of Labor and Congress of Industrial Organizations merged into the AFL-CIO, becoming the largest labor union in the United States

1956

2/2/1956 - Secretary of Board of Education requesting the Township make arrangements with the State of NJ Health Department to purchase Salk Vaccine for the inoculation of all eligible school children.

1957

4/12/1957 - Salk Vaccine was sent to Board of Education Manchester Township

4/1/1960 - Township Ordinance allowing New Jersey Natural Gas to lay, maintain, and operate its conductors, mains and pipes in a section of Manchester Township.

5/6/1960 - Manchester Township was granted the permission for the water company and sewerage system to be known as the Manchester Water and Sewerage Corporation.

3/18/1982 – The Township Committee adopted a Fire Prevention Code.

3/15/1984 – Mr. Portash announced that the State of New Jersey ordered all publicly owned landfills closed. The Whiting Landfill would closed by August.

3/15/1984 – The Township Committee applied for Green Acres funding to develop Harry Wright Park in the Whiting Section of Manchester.

6/21/1984 – Mr. Portash presented a plaque to Abel Kiviat. Mr. Kiviat was the winner of the Olympic Silver Medal in the 1912 held in Sweden. He is the oldest living track and field Olympic winner.

7/16/1984 – A formation was held for the purpose of entering into an agreement with Ocean County for the establishment of a co-operative means of conducting certain community development activities.

11/8/1984 – The Township Committee passed a resolution urging the New Jersey Department of Environmental Protection to conduct an investigation of the effects of the Ciba-Geigy ocean outfall line.

1985

4/15/1985 – Mr. Portash reported that three wells were found to be contaminated in the Richard Estates section of Manchester off of Route 571 next to the Ocean County landfill.

1/3/1985 – An Order was received from the Ocean County Board of Taxation that a revaluation must start immediately. Some work will be done by a consultant but most will be done in-house.

1/3/1985 – After a Charter Study Commission developed a minority and majority report. One of the differences was noted was the selection of the Mayor. It was decided that starting in 1986; the Mayor and Vice Chairman will be rotate among the

Committee. Each Committeeman will have the opportunity to serve as Chairman and Vice Chairman.

1/24/1985 – Mr. Portash was directed to investigate the feasibility of enlarging the present town hall by adding three stories to the back of the building.

1/24/1985 – An Ordinance was introduced to establish a Planning Board and Zoning Board in the Township.

1/24/1985 – A request was made by Mr. Fellows of Read and Associates for a final site engineering inspection of the MUA's new water storage facility on Highway 37.

4/18/1985 – The Township Committee granted permission to have certain wells tested in Richard Estates for possible contamination.

6/20/1985 – Municipal Clerk, Manuela Herring, submitted her letter of Retirement after 27 years of service to the Township.

7/18/1985 – Bids were accepted to add a computer system to the Board of Inspections.

7/18/1985 – An ordinance was adopted to license, regulate and fix fees for businesses required to be licensed in The Township of Manchester.

7/18/1985 – Pauline McCallum was appointed Municipal Clerk for a three year term.

7/18/1985 – A resolution was passed opposing Assembly Bill A-3298 that would move all Vital Statistic Offices to the County.

1986

1/23/1986 – The Township adopted a noise ordinance. Mr. Portash stated that we now have a way to control the noise legally.

5/15/1986 – The Committee passed a resolution in opposition of enactment of legislation that would license and regulate salt water fishing in the United States.

9/29/1986 – A special meeting was held to discuss the application of the Gilbert Motel on Route 37. A resident, Mr. Varelli, gave his opinion in opposition of the hotel. His family owned property adjacent to the proposed motel.

10/2/1986 – Mr. Terkelsen recommended that the Planning Board review the Highway Development Ordinance again for the purpose of eliminating objectional projects on Route 37. This is a rural town. We don't want to spoil the rural

atmosphere. We don't think motels, hotels, skating rinks, bowling alleys, etc. will be good for the highway development on Route 37.

1987

1/5/1987 – Mr. Portash announced that 1987 marked his 25th year in public service to Manchester Township.

1/15/1987 - The Township entered into a contract with the Ocean County Board of Chosen Freeholders to establish a new branch library known as Lot 2, block 48 situated and off Colonial Drive in Manchester Township.

1/15/1987 – The Kimball-Manchester Medical Center has broken ground for a medical facility to serve the residents and public of Manchester. The Township will appropriate \$25,000.00 to the facility as per N.J.S.A. 44:5-2 and N.J.S.A. 44:5-10.2.

2/19/1987 – A plaque was presented to the Whiting Volunteer Fire Company on their 50th year of service to the community.

2/19/1987 – The Committee passed a resolution opposing to the dumping of ash in the Ocean County Landfill that is coming from the County's burning facility in Waretown.

2/19/1987 – The Second Reading of a bond ordinance was adopted for the construction and expansion of the existing municipal building.

4/28/1987 – The award of the bid for the construction of the new municipal building was awarded to Patock Construction Company in the amount of \$3,767,608.00.

4/20/1987 – Mr. Przywara, Environmental Health Coordinator for the County stated that polluted wells have been found on Northampton Boulevard between Seventh and Eighth Avenues, and Parkview Boulevard from Eight to Ninth Avenue. Some residents were advised not to drink, cook or shower with water from the wells.

9/17/1987 - After reviewing documents from the Pine Lake Park Citizen's Committee, Mr. Portash urged the New Jersey Department of Environmental Protection to immediately conduct a Phase 2 of the plume study that was done five years ago of all wells.

9/17/1987 – Mr. MacIver of the Manchester MUA gave an update on the reporting of contamination in wells in Pine Lake Park . It was found that 121 had no detection, 127 had level one contamination and 71 wells had level 2, 3 and 4.

9/17/1987 - The Township Committee determined that after tests by various departments, there presently exists in the area known as Pine Lake Park, the surface and ground waters of one or more contaminants, in such quantities and durations as are or may be injurious to the human health and welfare of residents of Pine Lake Park.

9/17/1987 – Mr. Portash stated that today was the 200th Anniversary of the signing of the constitution of the United States.

11/12/1987 – A Resolution was received from the County of Ocean to have Pine Lake Park declared eligible for spill compensation.

12/14/1987 – Mr. Portash discussed the Pine Lake Park Water Pollution Problem. He suggested that a lawsuit be filed against the State Department of Environmental Protection and State of New Jersey for failure to adequately protect the water supply, which is their direct responsibility.

1988

1/21/1988 – The Township Committee was to do a feasibility study to see if ASARCO Lake could be used as a water supply.

1/21/1988 – Tom Lucey, A resident of Pine Lake Park stated that the residents of Pine Lake Park are taking roll in their local government. They will no longer tolerate being the stepchildren of the community.

1/21/1988 – The President of Leisure Knoll Assembly spoke about the noise at Reade Manufacturing.

1/21/1988 – A letter was received from the New Jersey Department of Environmental Protection stating that groundwater has been found to be polluted.

2/25/1988 – A resident commented with regard to 300 single family units being turned into 700 senior units. He was concerned about density.

4/27/1988 – A committee was formed to represent Manchester Township in negotiations with Dover Township, the Ocean County Health Department and Ciba-Geigy for problems caused by their Toms River plant.

5/19/1988 – A resident spoke about the severe forest fire in 1982 and the need for a north/south road connection between Route 530 and Route 37.

5/19/1988 – The Township Committee mentioned a recent accomplishment of the Pine Lake Park Association for a Better Community. This was the passing of an 8 million dollar bill in the Senate and Assembly that will bring potable water to the entire affected areas.

7/21/1988 - Abe Beacken spoke about everyone's concern about polluted water and the property owned by Ciba Geigy. He suggested that monitoring wells be placed around the landfill.

8/10/1988 – Mr. Goldt announced that Andrew Valmon will be participating in the 1988 Summer Olympics in Seoul Korea. Mr. Goldt asked the Mayor's permission to obtain an Olympic flag to fly in Mr. Valmon's honor.

8/18/1988 – A letter was received from New Jersey Department for Environmental Protection. The letter refers to justification to install ground water monitoring wells at South Brunswick Asphalt on Route 37.

8/18/1988 – Mr. Rizzolo resigned as Chairman of the Pine Lake Park Association for a Better Community as he has accepted an offer to run for Township Committee.

10/20/1988 – Mr. Portash called for a moratorium on construction in Pine Lake Park until demand for water is deemed adequate by the Engineers of the Manchester Utilities Authority.

1989

3/15/1989 – [The United States Department of Veterans Affairs was established](#)

7/20/1989 – The Committee adopted a resolution urging the Senate and House of Representatives to act immediately in line with President Bush's request to amend the Constitution of the U.S. declaring the desecration of the American Flag an illegal act.

8/17/1989 – A Resolution was adopted enacting a construction moratorium in the ground water impact area of Pine Lake Park and Savannah Acres of the Township of Manchester.

9/5/1989 – An Ordinance was introduced to authorize an election to determine the necessity for a Charter Commission to study the charter of the Township of Manchester.

9/15/1989 – A special meeting was held and ordinance #89-378 was rescinded due to the fact that petitions have been filed for a recommended change in the form of government of Manchester Township.

9/21/1989 – Mr. Murray announced that for the next six months, Township meetings would be held in the High School Auditorium due to the renovation of the old town hall.

10/19/1989 – Mr. Portash announced that the cost of the special election will cost approximately \$15,111.50 plus the cost of postage which will run between \$4,000 & \$6,000.00.

11/15/1989 – Correspondence was received from Edmund Glasner, Esquire regarding settlement in a pending litigation. As part of the settlement, Mayor Murray agreed to resign at the end of 1989 from public office.

1990

1/19/1990 – Mr. Portash reported back to the Committee on the public hearing on application before the BPU for increased Host Community Benefits on January 8, 1990

2/15/1990 – The Committee passed a resolution authorizing the institution of a counterclaim against PBA Local 246. The primary basis of the suit concerns the rescission of certain probationary promotions within the Manchester Police Department.

3/8/1990 – Mr. Rizzolo announced the untimely death of Township Administrator Joseph Portash and asked for a moment of silence.

3/8/1990 – An ordinance as introduced renaming Colonial Drive to Joseph S. Portash Memorial Boulevard.

3/21/1990 – The Township Committee passed a resolution petitioning the State legislature to review, study and re-examine the manner of school funding.

3/21/1990 – The Township Committee passed a resolution authorizing the payment of a lump sum benefit in the amount of 58,721.31 to the estate of Joseph Portash.

4/24/1990 – [The Hubble Space Telescope was launched.](#)

5/17/1990 – Mr. Rizzolo introduced the new Mayor-Elect and the council-elect Mr. Cicalese, Mrs. Buhr., Mr. Fusaro, Mr. Vanderziel and Mr. Maschuci. Mayor –Elect Cameron was not present.

5/17/1990 – Mr. Rizzolo asked the Governor to declare an emergency in Pine Lake Park. The cross streets are in horrendous condition, due to the MUA contractor going bankrupt and not completing the project of water installation.

6/6/1990 - Mr. Rizzolo tried to get the budget approved but did not have approval from the State at this time.

6/21/1990 – Mr. Rizzolo mentioned that tonight was the last meeting with this form of government. He thanked each and every person who worked for the Township for all of their hard work and dedication.

6/21/1990 – An Ordinance was adopted establishing the minimum fire safety standards.

6/29/1990 – A special meeting was held to try and get the budget adopted. Ms. Gawales reported that the State would not grant approval the budget until an amendment to the budget is read.

6/29/1990 – Janice Gawales submits her resignation to the Township and a resolution was passed paying her \$23,415.00 for accumulate sick leave.

6/29/1990 – Mr. Rizzolo gave a closing statement and felt the 1990 budget was not adopted because they did not have help from the Township Auditor.

7/1/1990 – The first meeting was held with the Mayor-Council form of government. Mayor Cameron was sworn into office as the first directly elected Mayor of Manchester. The members of council sworn in were Councilwoman Buhr and Councilmen Cicalese, Fusaro, Maschuchi and Vanderziel. Mr. Vanderziel was elected Council President.

7/1/1990 – The new Council introduced an ordinance repealing Ordinance No. 90-104 "An Ordinance designating Colonial Drive as Joseph S. Portash Memorial Boulevard.

7/2/1990 – The Township released a press release concerning the mismanagement of funds by the prior administration.

7/10/1990 – Mr. Fusaro commented with regard to the property swap with the landfill. Four new fields will be built for the Little League.

7/16/1990 – Mayor Cameron stated that the Township is in a very serious financial bind. Application was made to the State to provide sufficient funds to carry us through.

7/16/1990 – The Ocean County Prosecutor’s Office issued a press release concerning a request for assistance from Manchester Police regarding the dumping of municipal records at the Ocean County Landfill. Financial documents were recovered.

7/16/1990 – Mayor Cameron stated that the Township has many hardworking people and would not take one penny from the Township. They deserve respect and admiration.

7/17/1990 – The State of New Jersey took over the fiscal affairs of the Township.

8/2/1990 – President Saddam Hussein leads the deployment of 140,000 Iraqi troops in the Invasion of Kuwait.

8/14/1990 - Mr. Cicalese sent a letter to Congressman Saxton regarding Manchester getting its own zip code and post office.

9/18/1990 – Henry Kriwinsky of Oak Knoll came forward and he stated he represented fifty families in Oak Knoll. He was there to complain about the repulsive odor. He was worried about the future development of the landfill and contamination into the water supply.

10/9/1990 – Correspondence was received from the Superintendent of Schools asking Council to waive building and permit fees for the new elementary school. '

10/9/1990 – Mr. Cicalese reported that the Naval air Engineering Center has begun cleanup of the pollution at the facility.

10/24/1990 - A special meeting was held to discuss conceptual plans of 4,000 homes at the Heritage minerals site.

11/20/1990 – A Public Hearing was held on the Green Acres Application relative to the park in Holly Oaks.

1991

1/17/1990 – Operation Desert Storm – The United States leads 34 coalition in response to Iraq's invasion of Kuwait.

5/15/1991 – Mr. Vanderziel announced that a transition bond was needed to clean-up the incorrect expenditures that took place.

6/3/1991 – A letter was received from the State of New Jersey Department of Community Affairs that \$1,750,000.00 will be allocated to Manchester Township for property tax relief.

7/16/1991 – Mr. Foster, Township Attorney, explained the Municipal Vacancy Law and how the vacant Council seat was filled after the untimely death of Councilwoman Buhr.

7/16/1991 – The Township Council agreed that the expansion of the Ridgeway Fire House should be approved. However, it was agreed that the original allocation of \$250,000.00 was not enough to add a nutrition sight to the facility.

1992

3/10/1992 – Mayor Cameron announced that a sign will be posted at every entrance to Manchester Township that this is the home of Olympic Champion Andrew Valmon. Mr. Valmon won a gold medal at the 1988 Olympics in Seoul, Korea and a gold medal at the 1992 Olympics in Barcelona, Spain.

3/18/1992 – Mayor Cameron announced that a portion of the Heritage Minerals Tract has become contaminated with radioactive residue material.

3/18/1992 – John Vitale of the Cultural and Historical Committee reported that they are trying to preserve the one room school house.

4/29/1982 - Riots in Los Angeles are spurred by the acquittal of four Los Angeles Police Department Officers accused in the beating of Rodney King.

4/22/1992 – Art Abline, Emergency Management Coordinator, stated that the Ciba-Geigy clean up was completed.

8/16/1992 – Hurricane Andrew, a Category 5 hurricane devastates south Florida.

1993

1/1993 – William Jefferson Clinton became the forty-second President of the United States.

2/26/1993 – World Trade Center Bombing – A truck bomb exploded in the parking garage under the World Trade Center in Manhattan, killing six people and injuring 1,042 others.

7/3/1993 – The first Manchester Day was held.

7/20/1993 – Mayor Cameron reported that she wholeheartedly supports the action of the Council in dissolving the MUA.

8/19/1993 – Councilman Cicalese spoke about the unwritten law in Trenton called the “Manchester Law” which is whenever in the future, they walk into a Township where they find municipal corruption anywhere, they will immediately take over every other authority within the Township to include the School Board.

11/23/1993 – Mayor Cameron announced that the municipal building will be smoke free as of December 1, 1993. This is required by State statute.

12/6/1993 – The Dorsey bill was passed this year. It requires that all Townships provide a level of service to private communities.

1994

2/24/1994 – Mayor Cameron reported that she had the pleasure of going into the new ShopRite. She said it was going to be the largest on the East Coast.

3/16/1994 – Mayor Cameron issued a statement to say that with the plea of Mr. Varelli, the last chapter of the criminal corruption case in Manchester Township is about to close.

3/24/1994 – Mr. Ebanneau explained that a bond ordinance was passed about a year ago to include the purchase of police computer equipment. An IBM computer system was purchased in the amount of \$147,875.93 for the purchase of this system to bring out Police Department into the future.

3/24/1994 - The Township no longer used the Advance News as a legal newspaper after Mr. Varelli's indictment.

4/12/1994 – A Helicopter crash occurred off Harry Wright blvd. A private businessman left New York bound for Atlantic City when something went wrong and the helicopter crashed into a wooded area off Harry Wright Blvd.

6/30/1994 – Mayor Cameron reminded everyone that today is a historic day. Four years ago today, former Mayor Rizzolo and a few other people were pulling all of the files out of this Township and were dumping them into a truck. The truck was being driven down to the Landfill and dumped into the sludge.

7/1994 – Marie Pellecchia appointed Municipal Clerk.

9/22/94 – Marge Camposano of Holly Oaks asked about getting the traffic light at Route 70 and Green Acres Road. Mr. Fusaro said the Township was not paying for the light. The offer for Mr. Hesse to pay for the light has not been withdrawn. Mr. Ebenau has verified that.

11/15/1994 - Mr. Cicalese felt the Township could not afford a part-time Recreation Director at this time. He felt that someday he hoped to see the position expand into full-time.

11/29/1994 – Mr. Cicalese attended the lake meeting with Council President. The Public Works Director did not feel that could make Pine Lake a viable asset to the Township. He recommended that the Council and Administration look into having it dredged.

1995

1/26/1995 – Mr. Fressola asked the Council to contribute \$5,000.00 to a fund to save the Lakehurst Naval Base.

4/4/1995 – A forest fire affected the Whiting area. The developments of Wynnewood and Fox Hollow were evacuated.

4/19/1995 – Oklahoma City Bombing – A bombing killed 168 and wounded eight hundred.

6/29/1995 – An ordinance was adopted establishing the position of Deputy Director of Public Works.

7/1/1995 – Mayor Cameron Proclaimed July 1, 1995 Manchester Day.

7/6/1995 – Chief Harold Payne resigned as Chief of Police.

7/27/1995 – The Township advertised for bids for the construction of a new Manchester First Aid Squad on Colonial Drive.

8/24/1995 – The Township applied for a grant with the DEP for the restoration of Pine Lake.

10/12/1995 – The Manchester First Aid Squad saved a person at ShopRite by using the new defibrillator.

11/17/1995 - A permit application was filed with the New Jersey Department of Transportation for improvements to the intersection at Route 70 and Colonial dr.

12/14/1995 – The Committee adopted an alcohol and drug testing policy for all CDL employees.

1996

5/9/1996 – A weeping cherry tree and a plaque will be planted dedicated to Staff Sgt. Cheryl Turnage who died in line of duty for our Country.

5/23/1996 – The Township would now offer a three year dog license.

6/29/1998 – Mayor Cameron was presented with a plaque and flowers for her dedication and service as Mayor of the Township.

6/29/1998 – Thomas McCallum announced his retirement as Chief of Police. He enjoyed his 33 years of service to Manchester Township.

6/29/1998 - An ordinance was passed establishing the Department of Public Safety.

7/1/1998 – Mayor Fressola was given the Oath of Office as Second elected Mayor of Manchester Township for a four year term.

8/10/1998 – Ms. Lauffer reported on the status of the zip code change. Around 80 percent of the residents were in favor of it.

1999

1/11/1999 – Tom Thomas, Township Planner said that draft amendments to the land use ordinance were received. Most of the amendments have to deal with the Pinelands Regulations adopted in 1996 and the Comprehensive Management Plan requires that the Township amend their ordinances to comply with same.

5/21/1999 – Marianne Borthwick was named the 1999 Caregiver of the year Award by the Epilepsy Foundation of New Jersey.

7/26/1999 – An ordinance was defeated to change the date for municipal elections from May to November.

9/27/1999 – An Ordinance was adopted establishing a 35 mph speed limit on Wilbur Ave.

10/25/1999 – An Ordinance was adopted amending the Alcoholic Beverage License to include Alcoholic Beverage I.D's.
