<u>Elaine Baumeister – 30C Buckingham Dr.</u>: Ms. Baumeister spoke regarding Resolution #15-253 and asked how this meets the existing housing need. Ms. Baumeister was concerned with all of the empty houses in the senior villages and said they should be rented and be included in the Township's Affordable Housing requirements. Mr. Weiner said that the Ingerman Company did an extensive report and our demographics meet the need for this proposed project.

<u>Hank Glen – 29 Wycliffe Rd</u>.: Mr. Glen questioned Resolution #15-251 appointing Mr. Trimboli as Special Labor Counsel. Mr. Weiner said it was an ongoing case and deferred any further comments to the Township Attorney, Angela Koutsouris. Ms. Koutsouris said she was not familiar with the details. Ms. Koutsouris said it was not good to switch attorneys in the middle of such a big case. She said she would contact Mr. Trimboli and familiarize herself with the case.

Seeing no further comments from the public, Mr. Weiner closed this portion of the meeting.
