Hank Glen – 29 Wycliffe Rd.: Mr. Glen commented with regard to the Zika virus and asked what the Ocean County Mosquito Commission was doing about it. Mr. Weiner said the Commission is keeping a close eye on the virus. Mr. Glen said he was concerned about the breeding of mosquitoes in water basins. They are overgrown. Mr. Weiner said he would ask the Commission to look into it. Mr. Glen commented on the Renaissance back road. The Renaissance Board of Trustees has the road closed except for emergencies. Someone has to be called if there is an emergency to open the gate. Councilman Vaccaro said the Board of Trustees should ensure that all emergency personnel should have keys to the gate for the back road.
