<u>Larry Lee – Country Walk</u>: - Mr. Lee asked why the Township was releasing escrows to the Kokes Organization. Mr. Wallis explained that the Township had to release what was legally required.

<u>Hank Glen – 29 Wycliffe Rd</u>.: Mr. Glen felt that the contracts with Hall Realty Appraisal were not beneficial to the Township. The property that was to be appraised has 525 feet of highway frontage and the land would be perfect for a commercial business. He was of the opinion that we should not use it for open space. Mr. Wallis felt the appraisal was necessary to determine the best use of the property.

Theresa Lettman - Pine Lake Park: Ms. Lettman was concerned with the proposed land swap for Green Acres. She felt the Township was not doing it the right way. A scoping hearing should be done before the appraisals. A scoping hearing would be beneficial to determine the best use of the property. Residents might have other suggestions.

Seeing no further comments from the public, Mr. Wallis closed this portion of the meeting.
