# MANCHESTER TOWNSHIP MEETING MINUTES March 10, 2014

The meeting of the Manchester Township Council was called to order at 6:00 p.m. by Council President Craig Wallis. The following statement was read by the Municipal Clerk:

#### **REPORTS**

**Mr. Weiner:** Mr. Weiner gave an update on energy aggregation. Stafford Township will be going out to bid in three weeks and we should have a recommended vendor. At that time, we can see if it is going to be a substantial savings for the Township. Mr. Weiner reminded everyone that the Rotary Fish Fry will be held on April 4, 2014. He has tickets for purchase.

**Mr. Fusaro**: Mr. Fusaro reported that Manchester Township had a ninety-eight percent tax collection rate. The Tax Collector's office collected over eighty-four million dollars in 2013. However, the most interesting fact was that over one hundred sixty nine thousand dollars was collected in late fees. The St. Patrick's Day Parade was held last weekend in Seaside Heights. The Manchester Police Department Color Guard marched in the parade. Next year Manchester will be having its 150<sup>th</sup> incorporation anniversary. The Mayor is interested in having a celebration. Mr. Fusaro will talk to Cassandra Colgate and hopefully a planning committee can be formed.

**Mr. Fusaro**: Mr. Vaccaro attended the Zoning Board meeting on March 7, 2014 and reviewed invoices for correctness that were on tonight's bill list.

**Mr. Frattini**: Mr. Frattini said in the past week he has received about 12 phone calls regarding resident's electric bills being doubled. Most residents have switched to an alternate energy company called Meridian. Mr. Frattini felt that energy aggregation should be researched very carefully. Mr. Wallis assured Mr. Frattini this topic would not be taken lightly. On February 27, 2014 Leisure Village West Emergency Notification Committee met with Art Abline. He answered questions from the residents. On February 28, 2014, Mr. Frattini went to the Whiting School where he read to the students for Read Across America.

**Mr. Wallis**: Mr. Wallis felt that the recent OEM meeting went very well. The Township volunteers take it seriously. One of the major issues right now is getting fuel. One of the Township pumps was not working but it has been fixed. Mr. Wallis also advised that the Fire Departments are being called out due to faulty smoke alarms. Mr. Wallis urged residents to change the batteries on their smoke alarms on a regular basis. This saves the Fire Departments from making unnecessary calls.

**Ms. Zsoldos**: Ms. Zsoldos announced that the Mayor's annual Legislative Day is coming up. It is held every year in Trenton. She will be attending with Mr. Vaccaro, Mr. Wallis and the Mayor. Pending legislation is discussed.

**Mr. Secare**: Mr. Secare said he was happy to report that Tax Appeals are down for this year. The deadline is April 1.
