MANCHESTER TOWNSHIP MEETING MINUTES March 11, 2013

The meeting of the Manchester Township Council was called to order at 6:00 p.m. by Council President Craig Wallis. The following statement was read by the Municipal Clerk:

<u>POLICE RECOGNITION AWARDS</u> - Chief Klimakowski presented Recognition Awards to Art Abline and Marisa Wilkins from the Office of Emergency Management for their efforts during Hurricane Sandy. Mr. Abline and Ms. Wilkins worked over 150 hours each during the first week of the hurricane to ensure the safety of the Township residents. Recognition awards were also awarded to Auxiliary Police Officers who volunteerd their time to the ensure the safety of the residents during the storm.

Mr. Wallis asked if any Council members had any comments on any items on the consent agenda.

Seeing no further comments from Council, Mr. Wallis asked if there were any comments from the public on any item on the consent agenda.

Hank Glen 29 Wycliffe: Mr. Glen asked how much did the Township distribute in LOSAP funds yearly. Mr. Secare said the exact amount was \$95,450.00. Mr. Glen felt it was a worthwhile cause but thought it could be more publicized to get more volunteers. Mr. Glen felt it was hard to believe that we are approving money for Concert Fest without a budget being adopted. Mr. Wallis said the Concert Fest was funded by grants from the County. Mr. Glen asked if the money could be used for anything else. Mr. Wallis said it has to be used for Concert Fest. It is a grant for the arts. Mr. Glen felt that the Township was incurring out of pocket costs for Concert Fest through overtime and other expenses. He felt that the money should be used to benefit the Township on a year long basis. Mr. Wallis felt that we should provide some recreational opportunities for the residents. The cost that the Township incurs is minimal.

Elaine Baumeister – LVW: Ms. Baumeister wanted clarification on Sustainable Jersey. Mr. Wallis said the Township has to be a member in order to obtain grants for renewable energy projects. Ms. Baumeister suggested having a public presentation on grants to understand where the money is coming from and where it is going. She did not have the time to research the programs.

Seeing no further comments, Mr. Wallis closed the public portion.

REPORTS

Mr. Weiner: On March 5, 2013, Mr. Weiner attended the Ocean County Senior Advisory Council meeting. They discussed major budget cuts at the Federal level that would trickle down to the County. The Council has been urging Congress and the President to look at discretionary cuts instead of across the board cuts. Further, Mr Weiner made residents aware that Social Security statements will only be available on line. The Governor announced his proposed budget. So far, there are no cuts to senior services, however, this is an election year and Mr. Weiner feels there will be some changes in the proposed budget to come. Mr. Weiner announced that May property tax credits will be reflected in the August tax bill. The date was changed because of the deficit due to Hurricane Sandy. The County budget will be introduced April 3, 2013 and he will give more information as he learns it. The Lakehurst – Manchester Rotary held their Fish Fry on March 8, 2013. The Rotary Raised over \$3,500.00 for the community. Mr. Weiner met with representatives from Plumsted Township. They are the first community to offer energy aggregation to their residents. Mr. Weiner wants to look at this more closely because he feels it will save the residents money. A third party energy supplier has saved Mr. Weiner a great deal of money on his electric bill. Programs like this would give Manchester residents more options to save money. Mr. Weiner suggested having a public presentation from NJ Cool to discuss the options and benefits of energy aggregation,.

Mr. Vaccaro – Mr. Vacarro and Mr. Frattini took a tour of the Mancheser First Aid to view their facilities and equipment. This tour helped familiarize them with the workings of the organization. On March 1, 2013 Mr. & Mrs. Vaccaro attended Read Across America at the Whiting School. They read a book to the children in honor of Dr. Seuss's birthday. It was a very rewarding experience for them. On March 8, 2013, the Vaccaro's attended the Lakehurst-Manchester Fish Fry. The food was excellent and the event was well attended. Also, on March 14, 2013 Mr. Vaccaro attended the swearing-in ceremony of Patrolman Michael O'Hara.

Mr. Frattini: Mr. Frattini recently went on a tour of the Manchester First Aid Squad. He learned what it takes to run an ambulance sevice and all the hard work the volunteers do. Mr. Frattini also read at two schools for Read Across America. It was a very rewarding experience. Mr. Frattini along with Mr. Wallis attended an OEM meeting. All emergency systems are back in place after Hurricane Sandy.
