### Manchester Township Council Meeting Minutes May 29, 2012

Mr. Wallis asked Council if they had any comments on the above ordinance. Seeing no comments from Council, Mr. Wallis opened this portion of the meeting to the public.

**Hank Glen – 29 Wycliffe Rd.**: Mr. Glen asked who had the idea to amend the ordinance. Mr. Wallis said it started with Administration and the Planning Board. Mr. Glen was of the opinion that if the Town Center Zone was opened up to multi-family it would become more residential and not commercial. By taking 100 acres for multi-family would not leave enough for commercial use. There would not be any land left for the town center. Mr. Wallis said we are not taking a commercial opportunity out of there. There has not been an interest in commercial use in that area. An apartment complex would bring in a ratable. Mr. Wallis said he did not see commercial for 46 years. A few people have approached administration to build commercial but they have always fell through. Mr. Wallis asked if a big box store could still fit into the area. Mr. Thomas said an apartment complex is a better ratable than a big box store. Ms. Zsoldos said that if an apartment complex was built, it would become the biggest ratable in town. Mr. Wallis added that he did not see school children being a problem. The complex would only add about 50 children.

The new CyberKnife procedure was discussed. It's the only Robotic Radio Surgery system in Ocean County. It treats both cancerous and benign tumors. Mr. Lund felt the Township is not cutting expenses. A public meeting should be held to inform the residents of the budget situation. Mr. Wallis said it is hard to cut expenses. Certain services are mandated as most of the Township consists of senior citizens.

<u>Marge Camposano</u> – <u>1781 Camden Ave</u>.: Ms. Camposano commented with regard to the newsletter that is forthcoming. She suggested mailing the information with the tax bills instead of the newsletter in order to save money. All pertinent information would go out in one mailing.
