MANCHESTER TOWNSHIP MEETING MINUTES September 22, 2014

The meeting of the Manchester Township Council was called to order at 6:00 p.m. by Council President Craig Wallis. The following statement was read by the Municipal Clerk:

REPORTS

Mr. Weiner: Mr. Weiner toured the new OEM facility in Monmouth County. It is a state of the art facility. Thirty Monmouth County municipalities have turned over their 911 dispatch to the County. He suggested that Manchester should look into transferring our 911 dispatch to Ocean County. Mr. Wallis said that Ocean County had updated their technology. Mr. Secare said he would look into the possibility of moving the Township's dispatch. Mr. Weiner attended a meeting of the Ocean County Senior Advisory Council. Over five million dollars in funding will be available. However cuts will be coming. Ocean County will be holding a flu clinic at Oliverie Funeral Home on September 27, 2014 from 2-4 p.m. He suggested calling the funeral home to make an appointment.

Mr. Fusaro: Mr. Fusaro attended the second meeting of the Zoning and Land Use review Committee. They had a guest speaker who spoke about trends in land use. Mr. Fusaro expected the group to finish up before Christmas.

Mr. Vaccaro: Mr. Vaccaro attended the Manchester Coordinating Council meeting and the biweekly for preparation of the agenda. He also reviewed the invoices for accuracy that were on the agenda for Council's consideration.

Mr. Frattini: Mr. Frattini mentioned a proposed bill in the legislature wherein municipalities will be required to have cameras in police vehicles. Fines collected from DUI's will help pay for the installation. Manchester already utilizes cameras in police vehicles. Mr. Frattini asked if the Township would be able to be refunded for the camera installation. Mr Wallis said he was not sure about that but about thirty five dollars from DUI surcharges would go to the camera installation. Mr Fusaro said the Township has done about one hundred DUI's since the beginning of the year.

Mr. Wallis: Mr. Wallis went to Pine Lake and met with residents to hear their concerns. The Public Works Department is awaiting approvals to lower the lake. Hopefully this will help to clean it up. Tracey Lynch wants to move more events to the lake.

Mr. Secare: Mr. Secare advised that the Township recently won a lawsuit against Jeffrey Jerman wherein there will be square footage restrictions when building on an undersized lot. This will ensure privacy for Township residents.

PUBLIC COMMENT

Ginny Martin – Renaissance: Ms. Martin did not agree with the Council's

decision on the recent land swap. She did not agree with the appraisal that was done by Hall Realty. Mr. Secare advised that the appraiser that the Township hired was very accomplished and respected in his field. The appraiser felt that the Route 70 properties held more value compared to the Pine Lake Park properties as they were commercial properties on highway frontage. Ms. Martin asked why Council wanted to get rid of the hockey rink. Mr. Wallis said the rink is in disrepair. It would take over one hundred thousand dollars to

fix it. It has not been used in several years. Ms. Martin asked Council for an update on energy aggregation. Mr. Weiner advised that the Co-op has hired a vendor and they are trying to get the best prices on electric. Electricity prices are dictated by the market. Several other neighboring towns have taken advantage of energy aggregation.

<u>Joann Kemp – Pine Lake Park:</u> Ms. Kemp thanked Mr. Wallis and Mr. Weiner for coming out to the lake to address resident concerns.
