Hank Glen – 29 Wycliffe Rd.: Mr. Glen commented on resolution #11-104. He felt that by putting off much needed improvements, the water tower would deteriorate. The longer the Township lets things go, it will cost more money to fix. Ms. Zsoldos explained that there was no grant money to help fund the

project so now the Township has to try other avenues to paint the water tower by possibly generating revenue from another cell tower. One way would be to solicit a cellular company to place an antenna on the water tower.

Fred Lund – **LVW**: Mr. Lund asked what the capital improvement was regarding resolution #11-104. Mr. Wallis explained that it was the rehab of the water tank and storm water drainage in Pine Lake Park. Mr. Lund also questioned the dollar amount of the projects. Ms. Zsoldos advised that it was \$400,000 for the water tower and \$500,000 for storm water drainage at Pine Lake Park.

Seeing no further comments from the Public, Mr. Wallis closed this portion of the meeting.
