## **ORDINANCES - Second Reading, Public Hearing and Final Action**

## #11-025 - AN ORDINANCE OF THE TOWNSHIP OF MANCHESTER, COUNTY OF OCEAN, STATE OF NEW JERSEY AMENDING CHAPTER 245 OF THE CODE OF THE TOWNSHIP OF MANCHESTER ENTITLED LAND USE AND DEVELOPMENT

Mr. Wallis asked Council if they had any comments on the above ordinance. Seeing no comments from Council, Mr. Wallis opened this portion of the meeting to the public. Mr. Fusaro stated that he was not authorized to vote on this item because he was not on Council for the first reading. Mr. Secare said he was correct.

**Robert Taylor – 1301 Scranton Ave**.: Mr. Taylor said he was here to oppose the cluster ordinance that was on the agenda. He submitted a map of the proposed area. Pinelands has done a study on endangered species that Mr. Taylor does not agree with. He has pictures to prove that there are endangered species in the area. He sent the pictures to Pinelands. If the land is cleared, there will not be anything left. Mr. Wallis asked if Pinelands responded to the documentation. Mr. Taylor said they had and the report from Trident Environmental was not accurate. There were plenty of endangered species in the area. Mr. Wallis said the Pinelands Commission has been very strict over the years. The Pinelands Commission says they are trying to protect some of the land by allowing clustering.. Mr. Taylor said that everyone that lives adjacent to Harry Wright Lake was told that the land was protected. It is up to Council to decide to protect the land.

<u>Theresa Lettman – 1401 Broadway Blvd. - Pinelands Preservation Alliance</u>: The area in question is south of Harry Wright Blvd. She objects to this ordinance because of the endangered species that will be affected. Ms. Lettman stated that the Pinelands Commission replied to Mr. Taylor's report by stating that once the application is received, they will review his report. However, Ms. Lettman felt that there were things Council could do to protect the environment. She suggested expanding the areas to the north and west of Roosevelt City. The documentation that they have does not point to any endangered species in that area. The bonus density should not be applied to lots that are not aggregated.

<u>**Robert Zappalorti** – 575 Toms River Rd, Jackson, NJ:</u> Mr. Zappalori is a Herpetological Consultant and did a study of the area in question. There are over 32 species of endangered snakes in the area. If rattlesnakes are in Roosevelt City, they should be protected. It is a poor planning decision to put homes where you know there are rattlesnakes. Avoiding additional homes south of Harry Wright Blvd. will protect the rattlesnake habitat.

**Darren Kross 1300 Scranton Ave.**: Mr. Kross opposes all building in the area in question. A beautiful section of land would be destroyed together with endangered snakes. Our children will never be able to see these snakes. We will not be able to bring this species back. Other areas should be considered.

Arthur Douglas -1720 Newark Ave.: Mr. Douglas has documentation of the snake on video. The best thing to do is to move the proposed area. He implores Council to use their best judgment and save the snakes.

<u>Richard Silver – 1300 Cabot Ave</u>.: Mr. Silver said at least five families would be impacted by this ordinance. Mr. Silver mentioned the Borough of Harvey Cedars. The residents are suing the borough because they are building sand dunes and the value of their homes is in jeopardy. Property values are going to go down in Roosevelt City and they would lose their wooded yards. Mr. Silver said the people affected would probably hire lawyers and lawsuits would be initiated. Mr. Silver did not want to see the Township have to pay for this.

<u>Greg Douglas 1301 Zeppelin Ave</u>. Mr. Douglas moved to Whiting twelve years ago from a suburban area. He wanted to raise his children in a wooded area with wildlife. His paradise is being threatened. He is asking Council to stop development south of Harry Wright Blvd. The endangered species do not have a say. Mr. Douglas read a poem from a middle school student who sees the impact of development in the Pinelands.

Mr. Weiner felt that this was an issue of timing. He wanted to hold off on the issue and have Tom Thomas present. Mr. Secare said he told Mr. Thomas not to be present because of Pinelands regulations. Mr. Wallis said this issue was heard by the Planning Board and Tom Thomas was present. He has a resolution from the Planning Board. The issue has to be acted on. The Pinelands Commission is a tough authority on their rules and regulations. This organization was put there to protect the Pinelands and he was ready to move forward.

Seeing no further comments from the public, Mr. Wallis closed this portion of the meeting.

The above ordinance **was offered** upon a motion by Mr. Reiter seconded by Mr.Wallis and **adopted** by the following roll call vote: Councilmen Trutkoff, Reiter, and Wallis; yea. Mr. Fusaro and Mr. Weiner abstained.

**Mr. Weiner:** Mr. Weiner commented with regard to legislation that would change the school board election to November. This is gaining momentum in the legislature.

**Mr. Reiter**: Mr. Reiter discussed the possibility of property taxes being changed. The idea is before the legislature. Property taxes make up about 54 percent of taxes raised in New Jersey. The New Jersey League of Mayors feels that the property taxes hinder people from moving into the State and is keeping home values down. The New Jersey League of Mayors suggests eliminating school taxes from the tax bill. This would be done by the State changing the school funding formula. This could save ten billion dollars in property taxes. However, the money has to come from somewhere. This could come from an increase in income taxes, sales tax or a tax on gasoline. More work has to be done. Governor Christie supports some of this plan. In conclusion, Mr. Reiter knows there is a change coming but does not know exactly when. Mr. Reiter wished everyone a happy holiday.

Mr. Trutkoff: Mr. Trutkoff welcomed Mr. Fusaro to the Council.

**Mr. Wallis**: Mr. Wallis added to Mr. Weiner's statement regarding the school election legislation. If the school budget is within the two percent cap it will not have to be voted on. Mr. Wallis welcomed Mr. Fusaro to Council and finds him to be smart and honest.

Ms. Zsoldos: Ms. Zsoldos congratulated Mr. Fusaro on his appointment to Council.

Mr. Secare: Mr. Secare welcomed Mr. Fusaro back to Council.

**Ms. Skibo**: Ms. Skibo welcomed Mr. Fusaro to the Council. She stated it is a great honor to serve as Clerk while he is on Council.
