REPORTS

Mr. Weiner: Mr. Weiner mentioned another dangerous accident on Route 70. He felt Council has a duty to petition the New Jersey Department of Transportation to improve the infrastructure in Manchester. He suggested a resolution be sent to the New Jersey DOT urging them to improve the infrastructure of Manchester roads improve traffic safety for Manchester residents. Mr. Wallis suggested placing it on the next Council workshop. March 2nd was Read Across America Day. Mr. Weiner read to a kindergarten class at Manchester Township Elementary School. Dr. Seuss day has a great impact on reading awareness. He had a great time reading to the students. On March 30th, the Manchester Lakehurst Rotary will be holding a fish fry. The money will be going to Rotary scholarship fund.

Mr. Fusaro: Mr. Fusaro spoke about highway safety. Manchester roads are deteriorating. A plan to fix the roads should be put into place. He also suggested that the Harry Wright Lake bike path be completed. It stops about 500 feet before the park entrance. He asked Ms. Zsoldos to get options from

Public Works to complete the project. He suggested putting it on the next workshop to see what could be done.

Mr. Reiter: Mr. Reiter read to the students of the Whiting School and Manchester Township Elementary School on Read Across America Day. Green Eggs and Ham was the student favorite. He attended the League of Mayor's Legislative meeting. Four separate committees met to discuss legislation regarding taxes, pension, general legislation and land use. Mr. Reiter is on the General Legislative and Finance committee. He gave an update on what is going on in the legislature.

Mr. Wallis: Mr. Wallis attended the First Aid meeting thanked them for all they do.

Ms. Zsoldos: Ms. Zsoldos advised that research was being completed to see if it was feasible for the Township to have electricity provided by an alternate company. Ms. Lapp talked to the JIF. Other companies can provide substantial savings. Budget forms have been distributed to Department Heads and discussions should begin shortly.

Ms. Skibo: Ms. Skibo announced that the Township received third place at a recent JIF safety meeting.

<u>Hank Glen – 29 Wycliffe</u>: Mr. Glen asked how things were progressing with the new well and water tower. Ms. Zsoldos explained that the Township is finalizing negotiations with a large developer to release water back to the Township.
