## Manchester Township Council Meeting Minutes November 22, 2010

The meeting of the Manchester Township Council was called to order at 6:00 p.m. by Council President Craig Wallis. The following statement was read by the Clerk:

### **REPORTS**

**Mr. Reiter:** Mr. Reiter commented on the Veteran's Day ceremony held at Town Hall and commended Mr. Stanziano for a job well done. He felt privileged to sit next to many decorated war veterans. Mr. Reiter also attended the New Jersey League of Municipalities Conference held in Atlantic City where he attended many beneficial seminars. Mr. Reiter announced that Mr. Stanziano was honored at the Mayor's Luncheon and received the Innovation in Governments award given out by the New Jersey Department of Community Affairs.

**Mr. Weiner**: Mr. Weiner attended the Ocean County Missing and Exploited Children's Advisory Commission meeting. They are working on developing a program with the audio and visual departments of area high schools to update videos on various topics such as cyber bullying and the dangers of social networking. On November 19<sup>th</sup> he attended a spaghetti dinner hosted by Pop Warner. It was a prosperous night for fundraising. Mr. Weiner wished everyone a Happy Thanksgiving.

Mr. Trutkoff: Mr. Trutkoff wished everyone a Happy Thanksgiving.

**Mr. Wallis**: Mr. Wallis announced that Veteran's Day at the high school was very successful. Veterans spoke to the students to remind them that the world they live in was not free. The students appreciated the Veterans coming to speak to them. The high school held their homecoming game against Monsignor Dovovan and they did very well.

**Ms. Zsoldos**: Ms. Zsoldos wanted to mention that Mr. Stanziano was not only recognized by the New Jersey Department of Community Affairs but also on the national level. Negotiations are still going on with the unions regarding concessions in their contracts in order to make the budget work.

**Mr. Secare**: Mr. Secare announced that the last meetings would be held with the non-police unions and he was optimistic that concessions would be made.

**Ms. Skibo**: Ms. Skibo wished everyone a Happy Thanksgiving.

Ms. Pellicano: None

Ms. Lapp: Ms. Lapp gave an update on the budget.

#### **Public Comment:**

**Fred Lund** – **LVW**: Mr. Lund read a statement to the Council regarding the budget. He felt that Council should review the budget again and make expense adjustments. Mr. Lund felt that the tax levy increase should be reduced completely or bring it to a level that is more realistic.

Patric Dambroski – 901 Seventh Ave.: Mr. Dambroski commented with regard to the budget. He felt that salary increases were too high as well as things labeled "other expenses" in the budget. This number could be shaved. He also went through the current fund bill list and was concerned with the cell phone bill. Mr. Dambroski did not understand the tax assessment. Shop Rite and the landfill were paying less for taxes than two blocks in Pine Lake Park. These things should be addressed in the budget. Mr. Secare suggested that Mr. Dambroski sit down with the Tax Assessor who could explain the taxes on the landfill. Ms. Zsoldos offered that there have been meetings with the landfill that have addressed Mr. Dambroski's concerns. Mr. Dambroski asked what the projected revenue would be for the proposed Wal-Mart. Mr. Secare advised that the taxes will be split with Toms River. They have been more than fair to the Township considering Manchester will only have 44 parking spaces in the proposed Wal-Mart. Mr. Wallis said that it will be Manchester Police Department responding to calls at the Wal-Mart. Manchester will get host community benefits for this. Mr. Dambroski felt with the decrease in state aid it is now time for the Township to cut expenses. Mr. Dambroski also noticed that pension contributions have increased as well. Mr. Secare advised that it is a state mandated obligation. The state has not made their contributions so they are pushing it off to the municipalities. Mr. Dambroski was of the opinion that when times get tough, expenditures have to be cut. He runs a restaurant business and when he does not bring in enough money, he has to cut his spending and find ways to save money. He felt taxes should not be raised. There are over four hundred foreclosed properties in Pine Lake Park alone. Mr. Secare advised that concessions have to be made somewhere. Mr. Dambroski felt that the PBA should make some concessions in salary rather than to see some of their co-workers be laid off. Mr. Dambroski asked what the town is doing to bring in revenue. Mr. Secare advised that the Township is selling land. Mr. Wallis explained that having businesses is what generates revenue. He said the chance of bringing in big businesses to Manchester, such as a Target, was slim. First of all, the Township does not have the land and if you go down Route 70 you are in Pinelands. The Pinelands Commission has strict laws concerning building.

Fred Lund – LVW: Mr. Lund commented with regard to lay off notices going out.

**Midge Schuck** – **PLP:** Ms. Schuck felt that Township should ask employees for a "giveback". It is time for all employees to give up a percentage. She felt that a ten percent salary cut across the board would help everyone to keep their jobs and their homes. The dollar has been stretched as well as Township services.
