# Manchester Township Council Meeting Minutes November 8, 2010

The meeting of the Manchester Township Council was called to order at 6:00 p.m. by Council President Craig Wallis. The following statement was read by the Clerk:

# Resolution #10-324 - RESOLUTION OF THE TOWNSHIP OF MANCHESTER, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING READING THE SFY 2011 MUNICIPAL BUDGET BY TITLE

#### Resolution #10-325 - INTRODUCTION OF THE SFY 2011 BUDGET

Ms. Lapp read a synopsis of the SFY 2011 budget. The loss of State aid made this a tough budget to prepare. Dwindling revenues added to the shortfall. The budget, as introduced, would raise taxes \$100.88 for an average home assessed at \$194,000. Mr. Weiner advised that he would be abstaining on tonight's vote because he had just received the final copy of the budget before the meeting. He did not have a chance to review it.

#### **Public Comment:**

**Midge Schuck - PLP:** Ms. Schuck commented that the safety of residents was foremost. She was against any possible layoffs of Township police. She suggested selling land as a way to gain revenue and grant money should be researched. Mr. Wallis advised that the Township pursues any available grants, but they are drying up. He further advised that not many people are buying land because development has been put on the back burner.

**Patrick Dombrowski – Seventh Ave.**: Mr. Dombrowksi was concerned with taxes being raised. He felt all Township land was over assessed already. Mr. Wallis explained that a re-assessment was ordered by the County a few years ago. This was done to distribute taxes equally. He felt that Mr. Lynch did a fair job. The Township would like to conduct a re-assessment every five years.

**Vince Cimino – Broadway Blvd**: Mr. Cimino commended the Police Department on the fine work they did.

**Steve Bates – First Ave.**: Mr. Bates felt that more numbers had to be crunched to get the budget where it needed to be. He suggested working from the top down.

**Mr. Cusack**: Mr. Cusack asked where he could get a copy of the budget. The Clerk advised that it would be available in her office.
