# Manchester Township Council Meeting Minutes October 11. 2011

# RESOLUTION #11-291 - RESOLUTION OF THE TOWNSHIP OF MANCHESTER, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING READING THE SFY 2012 MUNICIPAL BUDGET BY TITLE

The above resolution was offered upon a motion by Mr. Trutkoff, seconded by Mr. Vanderziel and approved by the following roll call vote: Councilmen Trutkoff, Reiter, Weiner, Vanderziel and Wallis; yea.

RESOLUTION #11-292 – SFY 2012 BUDGET – Diane Lapp gave a brief synopsis of the SFY 2012 Budget. The total amount of the SFY 2012 Budget is \$30,854,672.69. The miscellaneous revenues to offset that are \$10,302,554.42 and the total to be raised by taxation is \$20,552,118.27. Most of the increases are due to increased pension and healthcare costs. Debt has increased slightly due to two small low interest loans from Green Acres. There was increase in surplus. Some miscellaneous went up and a few went down which offset each other. It was a good year for our UCC which helped out tremendously. State Aid has remained flat at 3.2 million dollars. The Garden State Trust has increased. It is state aid for open space which has been taken off the tax rolls. There will be an increase of 2.6 cents on the tax rate. For an average house assessed at \$194,000.00, the increase will be about \$52.00 a year. The Public Hearing on the budget will be November 14, 2011 at 6:00 p.m.
