Manchester Township Council Meeting Minutes September 12, 2011

The meeting of the Manchester Township Council was called to order at 6:00 p.m. by Council President Craig Wallis. The following statement was read by the Deputy Municipal Clerk:

"Adequate notice of this meeting was provided in accordance with the Open Public Meetings Act, pursuant to P.L. 1975, Chapter 231. Said notice was advertised in the Asbury Park Press, Star Ledger and was posted in the lobby of the Municipal Building."

PROCLAMATIONS: The Deputy Clerk and the Township Attorney read proclamations for National Preparedness Month and the Tenth Anniversary of 9/11.

WORKSHOP:

- a. A-3285 Public Contract Bid Advertisements Mr. Vanderziel felt it destroyed the ability for bids to come in at a lower cost. Mr. Wallis opposes the bill. He felt that it stops the vendor from doing the investigation and pricing out what the job really costs. Mr. Reiter felt that we should have some input from the Purchasing Agent on this bill. Mr. Weiner felt that this would not give the tax payers the best price on a project. He also felt that it could cause litigation issues because change orders could go above and beyond the estimate. Mr. Wallis asked Ms. Zsoldos to get comments from the Purchasing Agent. This matter would be held until the comments were received.
- **b.** S-2883 Presidential Primary Mr. Weiner felt that it would be a cost savings all around. He was in support of the bill. Mr. Wallis said by moving it back to June, it would save money for taxpayers. Mr. Reiter and Mr. Trutkoff were in favor of supporting the bill. Council decided a resolution of support would be put on the next Council meeting.

Mr. Secare suggested that Tim Horn, Esquire of Villani & Decluca, attorneys for AMRS Liquor Holdings, LLC address the public. Mr. Horn advised that the premises will be completely renovated and opened as a sports bar. It will be at the same location as the old Center Ice. The business has been closed for a few years and if there are any zoning applications they will be made to the proper boards. Mr. Vanderziel asked if dancing will be an activity at the new sports bar. Mr. Callazzo, a member of AMRS Liquor Holdings, LLC advised that there is no plan for dancing at the location.

REPORTS

Mr. Weiner: Mr. Weiner attended the last concert at Harry Wright Lake. He saw the Bronx Wanderers. The band consisted of a dad and his sons. He enjoyed it thoroughly. On September 10, 2011, he attended the police promotion ceremony. Two deserving officers were promoted from Sergeant to Lieutenant. Mr. Weiner wished Lt. Mallard and Lt. Dolan success in all of their future endeavors. He also attended the Eagle Scout Court of Honor where he presented a silver eagle coin to Vincent DiPaola.

Mr. Reiter: Mr. Reiter attended the Bronx Wanderers concert at Harry Wright Lake. Cassandra Colgate and staff were congratulated for a job well done. Mr. Reiter advised that he and Mr. Vanderziel replied to a letter from Governor Christie regarding property tax reassessments. Mr. Reiter read some of the letter to the public. The letter stated that municipalities are confronted with increasing delinquent and unpaid property tax collection, but also face a vast number of assessed valuation appeals fostered by a declining economy. Municipalities have to bear their own share along with those of the school district. Mr. Vanderziel and Mr. Reiter went on to write in the letter that it could lead to critical financial difficulties. They understood it did not have an effect on the taxpayers; however, it did place a terrible drain on municipality's ability to remain under the 2% tax levy cap. Mr. Reiter and Mr. Vanderziel suggested that school districts bear their fare share and not allow them to use the municipality as a safe haven. The letter is on the Township website for the residents to review. He urged the Governor to help the municipalities in getting some relief for tax appeals. Mr. Vanderziel didn't think it was fair for the municipalities to bear the burden.

Mr. Vanderziel: Mr. Vanderziel asked that the letter to the Governor be part of the record and placed on the Township website.

Mr. Trutkoff: Mr. Trutkoff and the Mayor attended the Senior Bocce tournament held at Renaissance. The Mayor threw out the first Bellini. The Mayor also presented two senior softball awards. One was to the Renaissance Rebels who are the Manchester Senior Softball Champions for the tenth consecutive year.

Mr. Wallis: Mr. Wallis said times are tough. The municipality has to assume the burden of the tax appeals. The Township has to make up that money. A better balance has to be found. Mr. Wallis congratulated Lt. Mallard and Lt. Dolan on their recent police promotions. They were well deserved.

Ms. Zsoldos: Ms. Zsoldos, along with the Mayor, attended a meeting at the Governor's mansion. The Governor's speech thrust upon the recent storm. He commended all government officials and first responders for their first rate handling of the storm. Ms. Zsoldos commended our local emergency responders. The Township had to evacuate some residents and training really paid off.

Hank Glen – 29 Wycliffe Rd: Mr. Glen felt that the Township had to find a way to revaluate properties ever year. Mr. Wallis said they are looking at a revaluation. This would bring everyone back in balance. There is going to be a cost associated with it. It should probably be done every five years. Mr. Glen felt that with technology it should be a lot easier to do the revaluation. Mr. Wallis said a lot of the homes are in foreclosure. It has to be done house by house. Mr. Secare said the condition of the home is considered very closely during a tax appeal hearing. Mr. Glen also commented on a bill being paid to United Water and asked if the Township was still connected to them. Ms. Zsoldos said the bill was for some of the projects that were in process before the takeover and any inventory that was purchased from United Water.
