# **PUBLIC COMMENT**

Arlene Ruggierio – MHOA of Pine Ridge at Crestwood: Ms. Ruggerio advised that Manchester is in need of a rent control ordinance. She stated that residents have had a lot of rent increases at Pine Ridge and it is out of hand. Most of the seniors cannot afford to live there. Homes are empty. Rent has gone from approximately 300 to 500 dollars and it continues to go up. Ms. Ruggierio asked Council to consider a rent control ordinance.

**Natalie Burns – Pine Ridge at Crestwood:** Ms. Burns was concerned with the rent continuously being increased at Pine Ridge at Crestwood. Property taxes have gone up and the landlord has made significant improvements by replacing older units with newer larger units. The owner has passed these costs on to all the residents. Mr. Secare advised Ms. Burns and Ms. Ruggierio to give their names to the Clerk and they would be contacted to set up a meeting with the Business Administrator.

Hank Glen – 29 Wycliffe Rd: Mr. Glen commended the Department heads for resolution #10-276. Over \$400,000 that was budgeted was not spent in the 2010 Budget.

Sheryl Claus – Grinnell Ave: Ms. Claus commented on the new water restrictions on the east side of town.

**Marge Camposano** – **Whiting**: Ms. Camposano commented with regard to Harry Wright Lake being closed for pollution. She did not want to it be closed permanently and hoped Council would address the situation.
