## **REPORTS**

Mr. Weiner: Mr. Weiner congratulated Ms. Lapp on her reappointment. Mr. Trutkoff and Mr. Reiter have been a pleasure to work with and they will be missed. There have been tough times in the past few years but they made it through. Mr. Weiner wished them the best of luck in their next chapter of life. Mr. Weiner mentioned that Federal cuts in the Older Americans Act will amount to be seven hundred thousand dollars in cuts for the Ocean County Board of Senior Services. This can be detrimental to seniors and their caregivers. Mr. Weiner urged residents to contact their Congressmen on December 11, 2012 to voice their concerns over these cuts. Advocating for older Americans is imperative for Manchester and Ocean County.

**Mr. Fusaro:** Mr. Fusaro said it has been great working with Mr. Trutkoff and Mr. Reiter. Their experience, and dedication will be missed. The tree lighting was held on December 8, 2012. Ms. Colgate, staff and the Department of Public Works did a great job. The Office of Emergency Management has posted a link on the Township website for residents to register their cell phones for Reverse 911. Manchester Little League is holding open registration. The league takes tremendous care of the fields. Mr. Fusaro read the Public Works Report which mentioned diesel fuel used and that over 323 tons of bulk trash was removed.

**Mr. Wallis**: Mr. Wallis read the Manchester First Aid productivity report into the record. The Public Works Department is doing small brush clean up from Hurricane Sandy. The County will be doing the bigger clean up. The Recreation Department and Public Works did a great job at the tree lighting. Mr. Wallis attended a bigger town's tree lighting and it wasn't as nice. Mr. Wallis thanked Councilmen Trutkoff and Reiter for their hard work and dedication to the Township. They will be missed.

**Ms. Zsoldos**: Ms. Zsoldos gave an update on the storm clean up. Congratulations went to Ms. Lapp on her reappointment. Ms. Zsoldos wished Councilmen Trutkoff and Reiter well. She will miss them.

Mr. Secare: Mr. Secare wished Councilmen Trutkoff and Mr. Reiter well.

**Ms. Skibo**: Ms. Skibo advised that the County has certified the General Election. The successful candidates should be getting notification from the County shortly. Ms. Skibo said it is very difficult to say goodbye to Councilmen Reiter and Trutkoff. She wished them well and hoped they would stay in touch. Ms. Skibo said the Clerk's Office will always be here for them if they need help in the future.

**Ms. Pellicano**: Ms. Pellicano said it was difficult to say goodbye to Councilmen Trutkoff and Reiter. She will miss them.

**Chief Klimakowski**: Chief Klimakowski thanked Councilmen Trutkoff and Reiter for their dedication to the Township.

Mr. Reiter: Mr. Reiter thanked Art Abline for a job well done during Hurricane Sandy. Getting information from FEMA has been difficult. Construction on Route 530 has been a long process. The timing of the traffic lights should be a little longer. Mr. Reiter suggested Ms. Zsoldos should contact the County about it. Mr. Reiter has had an enlightening four and a half years. He appreciated when residents came in and got involved. Disagreements between Council members had only occurred a handful of times. There has been no animosity. Mr. Reiter thanked the Mayor for being proactive for the past twenty years. Mr. Reiter thanked the employees of the building they do a great job. Thanks went to Steven Secare for guiding him in the proper direction. Mr. Reiter wished Mr. Vaccaro and Mr. Frattini well.

Mr. Trutkoff: Mr. Trutkoff reiterated what Mr. Reiter said. He thanked everyone for their support.
