WIND ENERGY ORDINANCE:

Mr. Yodakis, overview of what Tom Thomas, Township Planner, covered all concerns.

Mr. Yodakis, limits large solar farms, 20 acres required, won't have solar in back yard, large plans before Planning Board, would consider buffers for approval.

Noise issue addressed, blinking shadows.

Pineland Commission looking at their solar & wind requirements, we would most likely use that. When they put theirs in place we will have to adopt that.

Mr. Czekanksi, why are we doing this?

Mr. Yodakis, cover the town now until Pineland has something.

Mr. Somerset, purposed to amend chapter, to cover area outside of Pinelands.

Mr. Yodakis, my understanding was to cover all until Pinelands is in place, not as familiar as Tom Thomas.

Mr. Somerset mentioned small wind energy system, 3 zones only, Ocean County Landfill.

Mr. Czekanski, restrictions on areas, Mr. Yodakis, yes large applicants must have 20 acres.

Mr. Czekanksi, solar in this area on roofs going on now.

Mr. Yodakis and Ms. Faustina, that is allowed.

Ms. Faustina asked if this ordinance was modeled from another town, Mr. Yodakis, yes.

Ms. Faustina, have Tom Thomas clarify Town Center, included in ordinance may create issues in the future.

Mr. Czekanski, is there enough acres there.

Mr. Somerset, yes, not one owner.

Mr. Vaccaro, Pinelands ruled abandoned regulated sites, also discussed large sites in Pineland Reserve area, don't want that. I think Tom Thomas covered everything in his draft.
