Duncan Prime, Attorney for the applicant. Wa Wa store and gas station, convert 2 regular pumps to diesel fuel. No change to footprint. Also change existing sign different advertisement. Only passenger vehicles and light trucks, no tractor trailers allowed, they can not fuel up at these pumps. Do not want a truck stop.

Ronald Klos, Engineer, Bohler Engineering, sworn in and accepted by board.

Replacing two regular pumps with diesel, not adding any, pumps will be self service, (allowed in New Jersey) existing kiosk will be removed not needed for self service, bollards will stay. Diesel is non flammable, 15,000 gal. underground tank. Change sign with new information, also no tractor trailers allowed.

Chairman Vaccaro, addressed the board with his concerns with the large amount of tax appeals the town will be facing again this year, loss of ratables and increase in tax dollars. The Planning Board approves the Master Plan for the township, recently approve amendments to zoning in the Town Center and High Way development. I would like to see more permitted quality businesses allowed in town rather than going to another town because Manchester does not allow their use. This could increase ratables along Route 37 and 70 corridors and help reduce taxes. This will also allow residents to use local business instead of traveling a distance and also creates jobs.

I would like the Board's permission to ask in writing for our Town Council to evaluate what we have designated as highway development, consider adding and or changing permitted uses in Town Center and High Way and other commercial development zoning.

Mr. Yodakis, what Chairman Vaccaro is asking for is to expand permitted uses in current zoning to allow more availability for business to be allowed in town.

Mr. Yodakis, Chairman Vaccaro has a good point, Board should ask Tom Thomas to look into this. Mr. Krasky, agreed. Mr. Barron agreed. Board all in agreement to write letter. Chairman Vaccaro will write letter to Town Council with Board's request.
