PROFFESSIONAL REPORTS:

Tom Thomas, discussed with board the request of the Town Council for the Planning Board undertake a preliminary investigation and public hearing to determine whether the Heritage Minerals meets the statutory criteria for designation as an area in need of redevelopment. This is the largest parcel in Manchester, 7000 acres.

Mr. Thomas explained the procedure, following Planning Board will hold public hearing on June 2, 2014, adopt a resolution submit to Town Council, may be some modifications. Create a re-development agency, usually governing body. Past had to do this thru commendation.

Mr. Liston, laws changed, allows property owners to do this without condemnation, overseen by Township.

Mr. Thomas, if approved, property will go thru normal site plan approvals for development. If approved largest area ever in the state.

Mr. Thomas distributed copies to the entire board and professionals a copy of Area in Need of Redevelopment Planners Report. Also supplied copies of the report for the Township Clerk, Council, Mayor and Business Administrator. Mr. Liston stated, board should review report and be prepared for discuss and ask questions on June 2, 2014

Mr. Thomas suggested it would be helpful to arrange for board members to visit the site.

Mr. Yodakis, commented it would be very good, he did this years ago and board members should see area. You can go on google earth and pull up site. Board secretary will arrange the trips.

Mr. Liston, regarding Wal Mart, in appellate, decision can be in one month or six months. Still looks favorable.
