#### **REPORTS**

**Mr. Vaccaro**: Mr. Vaccaro represented Council at the Planning Board meeting on November 2, 2015. He also attended a meeting with residents of Summit Park to discuss ways of fighting crime in their neighborhood.

**Mr. Frattini**: Mr. Frattini thanked Mayor Palmer on behalf of the Leisure Village West Knights of Columbus for making a presentation of the State of the Township. He also wished a happy birthday to the Marine Corps which is on November 10, 2015. He also gave a brief history of the Marine Corps.

**Mr. Wallis**: Mr. Wallis attended an Emergency Management meeting and they discussed recent events in the the Township and how they could have handled things better. He also met with Senator Holzapfel to discuss the school funding formula issue and ways to make it uniform throughout the State. The High School will be holding a Veteran's Day Ceremony on November 12, 2015 to recognize Veteran's and he hoped everyone would attend.

**Mr. Fusaro**: Mr. Fusaro also attended the Summit Park meeting and congratulated Chief Parker for doing an excellent job answering resident questions. On November 2, 2015, he attended the Planning Board meeting to present the recommendations for the Community Development Advisory Committee (CDAC) on the amendments to the Master Plan. The CDAC committee was made up of Councilmen, Planning and Zoning Board members and members of other various agencies to discuss ways to bring in new commercial business into the Township. On November 8, 2015 he attended an Eagle Scout Court of Honor for Kyle Doctor. Kyle was presented with a proclamation and an Eagle Scout Coin. Manchester has had twenty-one Eagle Scouts in twelve years. The rank of Eagle Scout is a remarkable accomplishment.

**Mr. Weiner:** Mr. Weiner updated a resident who had a question on property maintenance issues. He spoke with the Zoning Officer and she is working on the issue. The Chili Cook Off and bonfire will be held at the Pop Warner field on November 13, 2015. Also the Township will be holding their Veterans' Day Ceremony on Wednesday, November 11, 2015.
