Roll Call: Mr. Cook-yes, Chairman Di Giore-yes, Mr. Foor-yes, Ms. Borthwick-yes.

New Business: Mr. Di Giore, Unsolicited newspapers, many people have complained, do not want these papers all over property. I recycle them, you can call 800 number in paper and tell them to no longer deliver paper.

Resident, member of public, I get it and I want it, good information in there.

Ms. Middaugh, ask company to pick it up.

Mr. Di Giore, I would like to put the 800 number on the web site.

Mr. Cook Environmental Commission education how to get rid of, I will write a small article.

TMR environmental impact study, Mr. Di Giore development on Route 70, from Planning Board commercial, restaurant, car wash, bank, from an environmental stand point nothing to object too, no wetlands, open space, endangered species, no concerns. Larry Lee, resident, new business, not moving from other shopping centers, we do not need this.

Mr. Cook, car wash will do oil changes also, recycle water and how do they get rid of oil, only concern..

Mr. Cook, soil tested, hydro studies, engineering, Commission to review storm water management report.

Ms. Borthwick, Planning Board has their Engineer review all the reports and make recommendations to the Board and the applicant for approval, this is what they are appointed by the Town to do, in the best interest of the town.

Ms. Middaugh, my back ground in storm water environmental issues, I should see it at least.

Mr. Di Giore, storm water basin.

Mr. Di Giore, abandoned railroad tracks, covered up Route 571, any plans to use.

Mr. Foor, during Bomarc cleanup active, still thing it is active.

Mr. Di Giore, track covered

Mr. Foor, must be recent, Bomarc moved from site.

Mr. Di Giore, very over grown.

Old Business: Barnegat Bay Estuary program

Mr. Cook, talk with Leutone Society help us with 20 million in grants from NJDEP. Storm water, non-point source pollution, talk with Ms. Henderson, see if I can meet with her and see if we qualify.

Alec Migetsky, oyster seeding with shells start oyster beds.

Mr. Foor, Toms River, oyster beds, protected area.

Mr. DI Giore, National Resources Inventory, Environmental Commission supposed to put together list every so many years. ANJEC grant, we did several years back cannot open files. I attend ANJEC Conference, seek help. Rowan group, NJ map produce your own maps, search by block and lot with this software. Choose streams endangered species, etc. Good tool for NRI.

Ms. Middaugh has CD report, <u>www.njmap</u>. Gave ANJEC CD files did not look st report yet. Mr. Di Giore look at site very good.

Heritage Minerals site, Ms. Middaugh, being discussed again.

Mr. Cook, so old not valid any longer.

Ms. Middaugh, meeting, go forward.

Mr. Foor, share your frustration, embarrassing that we have not seen them.

Resident, Public, again before the DEP, August meeting for comments. (public calling out from seats)

Resident Public, ask for CAFRA hearing

Resident Larry Lee, we have Hovnanian coming to speak at our village.

Manchester Coordinating Council, Judy Carmichael we asked them to come, they did not approach us.

Ms. Middaugh, lot of confusion, education, who is doing what.

Resident, Public, township meeting, when application does come it will be too late.

Mr. Di Giore, we will look at the CAFRA report.

Ms. Borthwick, CAFRA report is in the Clerk's office for the public review.

Ms. Borthwick, explain the Planning Board does not have any application from Heritage before them at this time, so the Township, the Planning Board and the Environmental Commission cannot make any comment on this or attend any private meetings they may be having in the villages.

Mr. Di Giore the Planning Board should give us more.

Mr. Foor, not much.

Ms. Middaugh, e mail among ourselves for information what is going on.

Mr. Cook, information cannot be discussed among ourselves only at meetings.
